## Membership Agreement

1. You and all concerning parties membership to 4 Star Tennis, Inc. begins upon the completion of this agreement. It will be assumed that your membership will remain unless other terms are verified and a written receipt is distributed by 4 Star Tennis, Inc. personnel. Please notify our staff as soon as possible of terminated or frozen memberships. 4 Star Tennis, Inc. operates on an automatic billing system, so bills are mailed up two weeks in advance.
2. Memberships are non-transferable and non-refundable. However, you can freeze your membership (have PAID time stopped and held until further notice.) You can freeze due to various personal reasons for up to six months. Termination can occur at any time, although allowances are not granted for lost time. 4 Star Tennis, Inc. holds the right to terminate or suspend memberships do to lack of, or untimely payments.
3. Completion of this contract verifies that each member has no disability, impairment, or medical condition that jeopardizes the safety of each individual on this agreement. This contract also verifies that each member has a clearance from their private practitioner to engage in exercise conducive to a health club. Members and their private guests using the facility do so at their own risk. Management shall not be liable for any damages and thereby forever release and discharge the club, owners, trainers, employees, and agents from any and all claims, demands, damages, rights or cause of action present and future, whether the same be known or unknown, anticipated, resulting from or raising out of the members and their guests use, or intended use of the facility and equipment thereof.
4. Members must present membership cards. Lost or damaged cards can be replaced. Membership cards are not transferable. Members are also urged not to bring valuables into the facility. All parties associated with 4 Star Tennis, Inc. are not liable for loss, theft, or damage to personal property.
5. Members must follow proper gym etiquette (putting away weights, using towels while perspiring, appropriate language) while in the facility, as well as any posted regulations. 4 Star Tennis, Inc. holds the right to suspend or terminate members who do not abide by these regulations.
6. Membership at 4 Star Tennis, Inc. shall not be denied on the basis of race, color, creed, religion, or origin. Any aspects of such matters shall never be a condition of membership.
7. NOTICE OF CONSUMER RIGHTS:
  - a. Our business' registration number with the State's Consumer Protection Division is e2189.
  - b. We are not required to carry a performance bond under the Maryland Health Club Services law because we do not accept more than three months payment in advance or charge initiation fees over \$200.00.
  - c. If the club is closed for a month or more, you are entitled to your choice of either an extension of the agreement or a prorated refund. If the closing is not the fault of the business, we are entitled to choose.
  - d. You have the right to cancel this agreement within three business days after receipt of a copy of this agreement. Cancellation must be in writing, and delivered in person or by certified or registered mail. If you cancel, you are entitled to a full refund of all monies paid.
  - e. If you become disabled for at least three months during the membership term and the disability is confirmed in writing by a physician, you are entitled to an extension of the agreement. Since we are exempt from the bonding requirement, we cannot collect payments during a member's disability extension so that we are not holding more than three months' payment in advance.
  - f. This notice is an integral part of the application and contract for membership.
